(i) *Contraction of the Lincoln (Parts of Lindsey) Foot-and-Mouth Disease Infected Area.*

Substitutes on the 5th November, 1933, the following Area for the Infected Area described in the Schedule to the Foot-and-Mouth Disease (Infected Areas) Order of 1933 (No. 76).

An Area comprising:—

In the county of Lincoln (Parts of Lindsey).

The borough of Louth.

The parishes of Skidbrooke with Saltfleet Haven, South Somercotes, Conisholme, Alvingham, North Cockerington, South Cockerington, Saltfleetby St. Clement, Saltfleetby All Saints, Saltfleetby St. Peter, Grimoldby, Stewton, Louth Park, Keddington, Legbourne, Little Cawthorpe, Manby, Little Carlton, Castle Carlton, Great Carlton, North Reston, South Reston, Muckton, Authorpe, Belleau, Claythorpe, Tothill, Gayton le Marsh, Withern with Stain, Strubby with Woodthorpe, Maltby le Marsh, Theddlethorpe All Saints, Theddlethorpe St. Helen, and Mablethorpe, and so much of the parish of North Somercotes as lies to the south of the road which runs from Conisholme via North Somercotes and Skidbrooke North End to Saltfleet.
