the said Benefice of Peakirk shall become and be the house of residence for the Incumbent of the United Benefice.

"4. That with the consent of the Dean and Chapter of the Cathedral Church of Saint Peter at Peterborough, as the Patrons of the said Benefice of Northborough (in testimony whereof they have caused their Common or Capitular Seal to be affixed to this Scheme), and with the consent of the Reverend Charles Edward Carnegie, now Incumbent of the said Benefice of Northborough (testified by his signing this Scheme), upon the union taking effect (a) all that detached part of the Parish of the said Benefice of Glinton and all that adjacent detached part of the Parish of the said Benefice of Peakirk which lie to the east of and adjacent to the Parish of the said Benefice of Northborough shall be transferred annexed for all ecclesiastical purposes to the Parish of the said Benefice of Northborough, and (b) all that detached part of the Parish of the said Benefice of Glinton which lies to the east of and adjacent to the Parish of the said Benefice of Peakirk shall be transferred and annexed for all ecclesiastical purposes to the Parish of the said Benefice of Peakirk.

"Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Peterborough has been duly given in the manner and within the time pre-scribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been

approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Peterborough.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 12th day of October, 1933, in the words and figures

following, that is to say:—
"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of a part of the Benefice (being a Rectory) of Bishop's Cleeve and the Benefice (being an United Benefice) of Woolstone with Oxenton, both of which Benefices are situate in the County of Gloucester and in the Diocese of Gloucester:

"Whereas Commissioners appointed at our request by the Right Reverend Arthur Cayley, Bishop of Gloucester, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the union of part of the said Benefice of Bishop's Cleeve with the said Benefice of Woolstone with Oxenton duly made their Report to the said Bishop of Gloucester and therein recommended such union and the terms for effecting the same and the said Bishop of Gloucester signified in writing his approval of the said

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said union based upon the terms recommended in the said Report:

"And whereas both of the said Benefices of Bishop's Cleeve and Woolstone with Oxenton are now full, the Reverend Thomas Jesson being the present Incumbent of the said Benefice of Bishop's Cleeve and the Reverend Clifton David Walker being the present Incumbent of the said Benefice of Woolstone with Oxenton:

"And whereas by a Resolution of the Parochial Church Council of Bishop's Cleeve dated the 3rd day of October, 1932, and duly communicated to us, the said Ecclesiastical Commissioners, the said Parochial Church Council have resolved that in the event of the union hereinafter recommended and proposed being carried into effect those persons who are inhabitants at the date of the Union of the part of the Parish of the said Benefice of Bishop's Cleeve proposed to be united with the said Benefice of Woolstone with Oxenton, shall, for the purpose of burial, be considered to remain parishioners of Bishop's Cleeve for twenty years after that date:

"Now, therefore, with the consent of the said Arthur Cayley, Bishop of Gloucester (in testimony whereof he has signed this Scheme), and with the consents of the said Thomas Jesson and Clifton David Walker (testified by their respectively signing this Scheme), we, the said Ecclesiastical Commissioners for England, do humbly recommend and propose

to Your Majesty as follows, that is to say:—
"1. That a part of the said Benefice of Bishop's Cleeve namely all that part of the Parish of such Benefice which is conterminous
