Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Edward, Leyton, situate in the Parish of Leyton, in the County of Essex and in the Diocese of Chelmsford:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Edward, Leyton,

situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend Henry, Bishop of Chelmsford (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said Parish of Leyton which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Edward, Leyton, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Edward, Leyton'.

trict Chapelry of Saint Edward, Leyton'.
"And with the like consent of the said Henry, Bishop of Chelmsford (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint Edward, Leyton, situate as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the Minister of the same church for the time being. Provided always that so long as the Reverend Robert Bren, the present Vicar or Incumbent of the Vicarage of the said Parish of Leyton, shall continue to be such Vicar or Incumbent all the fees or dues which may be received in respect of such publication, solemnization or performance at the said Church of Saint Edward, Leyton, shall be paid over by the minister thereof to the said Robert Bren.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Edward, Leyton, being

"All that part of the Parish of Leyton, in the County of Essex and in the Diocese of Chelmsford, which is bounded upon the north east by the New Parish of Saint Catherine, Leyton, upon the south east by the New Parish of Christ Church, Leyton, both in the said County and Diocese, and upon the remaining sides, that is to say, upon the south west and upon the north west, by an imaginary line commencing upon the boundary which divides the said New Parish of Christ Church, Leyton, from the said Parish of Leyton at the junction of Murchison Road with Francis Road, and extending thence north westward along the middle of Francis Road for a distance of 19½ chains or thereabouts to its junction with Leyton High Road, and extending thence north

eastward along the middle of Leyton High Road for a distance of 7½ chains or thereabouts to its junction with Hainault Road, and extending thence north eastward along the middle of Hainault Road for a distance of 13½ chains or thereabouts to the centre of the bridge which carries the Tottenham and Forest Gate Branch Line of the London Midland and Scottish Railway across Hainault Road upon the boundary which divides the said Parish of Leyton from the said New Parish of Saint Catherine, Leyton".

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar

of the said Diocese of Chelmsford.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 12th day of October, 1933, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken out of the New Parish (sometime District) of Saint Thomas, Kirkby in Ashfield, in the County of Nottingham and in the Diocese of Southwell:

"Whereas we are satisfied that the said New Parish of Saint Thomas, Kirkby in Ashfield, is a Cure wherein or in part whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular part of the said New Parish of Saint Thomas, Kirkby in Ashfield, which is hereinafter mentioned and described should be con-
