FUR TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY THE OVERTIME RATES FOR " FIVE DAY-A-WEEK " TIME-WORKERS AND THE GENERAL MINIMUM PIECE-RATES FOR HAND-FLESHING AND MACHINE-FLESHING OF LAMB SKINS.
