the point in the middle of the bridge which carries Walm Lane across the line of the Metropolitan Railway where the boundaries of the said New Parish of Saint Gabriel, Willesden Green, of the New Parish of Christ Church, Brondesbury, in the said County and Diocese, and of the said New Parish of Saint Andrew, Willesden, all meet, and extending thence north westward along the middle of the said line of railway for a distance of 78 chains or thereabouts to the point in the middle of the bridge which carries Dudden Hill Lane across the said line of railway where the boundaries of the said New Parish of Saint Andrew, Willesden, of the Parish of Willesden, in the said County and Diocese, and of the said New Parish of Neasden cum Kingsbury, all meet."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 9th day of November, 1933, in the words and figures following, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Leonard, situate at Dordon, in the Parish of Polesworth, in the County of Warwick and in the Diocese of Birmingham:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Leonard, situate at Dordon as aforesaid:

"Now, therefore, with the consent of the Right Reverend Ernest William, Bishop of Birmingham (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said Parish of Polesworth which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Leonard, situate at Dordon as aforesaid, and that the same should be named 'The District Chapelry of Saint Leonard, Dordon'.

"And with the like consent of the said Ernest William, Bishop of Birmingham (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint Leonard, situate at Dordon as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the minister of the same church for the time being.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Leonard, Dordon, being:---

"All that part of the Parish of Polesworth, in the County of Warwick and in the Diocese of Birmingham, which is bounded upon the west partly by the Parish of Wilnecote, in the said County of Warwick and in the Diocese of Lichfield and partly by the Parish of Kingsbury, upon the south partly by the last-mentioned Parish, partly by the Parish of Baddesley Ensor and partly by the Parish of Grendon, all in the said County of Warwick and in the said Diocese of Birmingham, upon the east by the last-mentioned Parish, and upon the remaining side, that is to say, upon the north by an imaginary line commencing upon the boundary which divides the said Parish of Grendon from the said Parish of Polesworth, at the centre of the bridge which carries the private road leading from Grendon Hall to Atherstone Road across the River Anker and extending thence westward along the middle of the said private road for a distance of 16 chains or thereabouts to its junction with Atherstone Road, and extending thence north westward along the middle of Atherstone Road for a distance of 40 chains or thereabouts to its junction with Sandy Way Lane, and extending thence south westward along the middle of Sandy Way Lane for a distance of 28 chains or thereabouts to its junction with Saint Helena Road and extending thence north westward along the middle of Saint Helena Road for a distance of 24 chains or thereabouts to a point opposite to the north eastern end of the fence which divides the close numbered 773 upon the Ordnance Survey Map of the Civil Parish of Polesworth published in the year 1924 on the scale of 25 inches to a mile and also upon the map or plan annexed to this Representation from the close numbered 785 upon the same maps, and extending thence
