The county of Lancaster, including all county boroughs and other boroughs geographically situate therein (excepting the county borough of Barrow-in-Furness, and the petty sessional divisions of North Lonsdale and Hawkshead).

The Order, which comes into operation on the 28th December, 1933, restricts the movement of swine into, out of, or within the Infected Area, and regulates the holding of markets, sales and exhibitions of swine therein.
