LAND DRAINAGE ACT, 1930.

*Somerset Rivers Catchment Board.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the Order made on the 28th October, 1933, in relation to the Scheme prepared by the Somerset Rivers Catchment Board, under Section 4 (1) (b) of the Act, making provision for the abrogation of certain of the powers of the Somerset Commissioners of Sewers; the constitution of three Internal Drainage Districts to be known as the Gordano Valley, the North Somerset and the West Mendip Internal Drainage Districts; the constitution of Drainage Boards for those Districts; the alteration of the boundaries of the Upper Axe, the Lower Axe and the Upper Brue Internal Drainage Districts; and for certain matters supplemental thereto.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.
