in the darkness and rush of water, to make his way to safety, to reach a part of the working where several of the colliers had gathered. The colliers then divided into two groups, one group seeking a way out by an airway and another group by a roadway which was flooded and obstructed by a mass of timber and rails which had been washed down by the water. Thomas took up the rear in the group that took the roadway, and when they succeeded in reaching safety he returned, at considerable peril to himself, to fetch the other group, who then escaped by the same route, Thomas being the last to leave.
