#### THE BANKRUPTCY ACTS, 1914 AND 1926.

The Board of Trade, with the sanction of His Majesty's Treasury, have appointed Mr. Walter Rackwood Cocks to be the Official Receiver for the district of the County Court

holden at Torquay (which as from the first day of March, 1934, ceases to be excluded from having jurisdiction in bankruptcy and in proceedings under the Companies Act, 1929) in addition to the districts of the County Courts holden at Exeter, Barnstaple and Taunton for which he is already appointed Official Receiver.

This appointment is to take effect as from the first day of March, 1934.
