THE BANKRUPTCY ACTS, 1914 AND 1926.

Whereas the Board of Trade by Order dated the 29th day of April, 1925, directed that as regards all bankruptcy proceedings in the High Court of Justice in which the initial of the first surname of the debtor or debtors was any of the letters G to O, Edward Parke, an Official Receiver of the Bankruptcy District of

the High Court should be constituted Official Receiver of the estates of the debtors in such proceedings.

And whereas by Order of the Board of Trade dated the 21st day of March, 1934, the said Edward Parke was appointed as from the 1st day of April, 1934, Senior Official Receiver attached to the High Court of Justice in Bankruptcy in succession to the Hon. W. J. H. Boyle, C.B.E.

Now therefore the Board of Trade do hereby appoint the said Edward Parke to be Official Receiver in the proceedings and of the estates in which the initial of the first surname of the debtor or debtors is any of the letters A to F.

And whereas by Order of the Board of Trade dated the 28th day of March, 1934, Sydney Walter Hood was appointed as from the 1st day of April, 1934, an Official Receiver attached to the High Court of Justice in Bankruptcy in succession to the said Edward Parke.

Now therefore the Board of Trade do hereby appoint the said Sydney Walter Hood to be Official Receiver in the proceedings and of the estates in which the initial of the first surname of the debtor or debtors is any of the letters G to O.

And it is further ordered and the Board of Trade do hereby direct that

(a) as regards the bankruptcy proceedings instituted under the Bankruptcy Acts, 1883 to 1926 which are pending in the High Court the said Edward Parke and the said Sydney Walter Hood shall for all purposes of the said Bankruptcy proceedings in which the initial of the first surname of the debtors is any of the said letters A to F or G to O respectively be the Official Receiver who shall be constituted the Official Receiver in the estates of the debtors as aforesaid in such proceedings and discharge the duties of Official Receiver in relation to such estates.

(b) as regards all bankruptcy proceedings which shall be instituted in or transferred to the High Court under the Bankruptcy Acts, 1914 and 1926, the said Edward Parke and the said Sydney Walter Hood shall for all purposes of the said bankruptcy proceedings in which the initial of the first surname of the debtors is any of the said letters A to F or G to O respectively be the Official Receiver who shall be constituted the Official Receiver in the estates of the debtors as aforesaid in such proceedings and discharge the duties of Official Receiver in relation to such estates.
