RURAL DISTRICT OF WARE.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an Order dated the 14th day of March, 1934, the Minister of Health has declared that, on and after the 1st day of April, 1934, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Rural District of Ware, namely:—

(a) In the several contributory places within the district:—

Sections 15, 16, 23, 25, 26, 28, 30, 32 and 33 comprised in Part II (streets and buildings).

Sections 34 to 38 (inclusive), 43 to 46 (inclusive) and 66 comprised in Part IV (in-sanitary provisions), and

Sections 52 to 59 (inclusive), 62 to 64 (inclusive) and 66 comprised in Part IV (infectious diseases).
