LAND DRAINAGE ACT, 1930.

EAST SUFFOLK RIVERS (EXCLUDING THE RIVER WAVENEY) CATCHMENT BOARD.

River Blyth Internal Drainage District.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a scheme submitted to him by the East Suffolk Rivers (excluding the River Waveney) Catchment Board under Section 4 (1) (b) of that Act, making provision for, *inter alia*, the constitution of a new Internal Drainage District to be known as the River Blyth Internal Drainage District and of a Drainage Board therefor, and for matters supplemental thereto: and that the Order will become final and have effect as an Act of Parliament, unless within thirty days from the date of this Notice a Memorial that the Order shall not become law without confirmation by Parliament is presented to the Minister by some person or body affected by the Order, and having an interest sufficient for the presentation of a Memorial.

A copy of the sealed Order has been deposited, together with a copy of the Scheme, as amended, and of the maps referred to therein, at the office of the Clerk of the Catchment Board, F. A. W. Cobbold, Esquire, 21, Tower Street, Ipswich, for public inspection for a period of thirty days from the date of this notice, and may be inspected during the ordinary office hours.
