of Stainforth and duly consecrated as aforesaid, shall be and the same is hereby substituted for the said old parish church of the same parish, and that such new Church shall henceforth be the parish church of the said Parish of Stainforth in lieu of the said old parish church of the same parish as fully in all respects as if the said new Church of Saint Mary, so hereby substituted, had been originally the parish church of the same parish: And we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned), do hereby transfer all the endowments, emoluments, and rights of or belonging to the said old parish church of the said Parish of Stainforth or of or belonging to the Vicar or Incumbent thereof, to the said new Church of Saint Mary (now being by virtue of these presents the parish church of the said Parish of Stainforth) and to the Vicar or Incumbent thereof and his successors for ever.

In witness whereof to these presents we, the said Ecclesiastical Commissioners for England, have set our Common Seal, and the said Leonard Hedley, Bishop of Sheffield, has set his hand and affixed his Episcopal Seal and the said William Stephen Fletcher has set his hand and affixed his seal this third day of May, in the year One thousand nine hundred and thirty-four.

RURAL DISTRICT OF WARMLEY.

In the rural district of Petersfield—
The parishes of Clanfield and Horndean and so much of the parish of Rowlands Castle as comprises the former parish of Idsworth and parts of the former Urban District of Warblington and of the former parishes of North Havant, Chalton, Bedhampton and Blendworth as the said former Urban District and Parishes were respectively constituted immediately before the 1st day of April, 1932.

In the county of West Sussex-

In the rural district of Chichester.

The parishes of Stoughton and Westbourne.

The Order will vary or extinguish all rights and privileges which would impede or interfere with its purposes and confer other rights and privileges.

To incorporate with the Order all or some of the provisions of the Gasworks Clauses Act 1847 and the Gasworks Clauses Act 1871.
