

the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District or New Parish for spiritual purposes to be taken out of the Parish of Rotherfield, in the County of Sussex and in the Diocese of Chichester:

“ Whereas we are satisfied that the said Parish of Rotherfield is a Parish wherein or in part whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular part of the said Parish of Rotherfield which is hereinafter mentioned and described should be constituted a separate District or New Parish in the manner which is hereinafter set forth:

“ And whereas there is within the limits of the said proposed separate District or New Parish a consecrated Church in use for the purposes of Divine Worship and such Church is named ‘ The Church of Saint Michael and All Angels, Jarvis Brook ’:

“ And whereas by a certain Deed bearing date on or about the 22nd day of March, 1934, and made or expressed to be made under the authority of the ‘ New Parishes Acts, 1843, 1844, and 1856 ’ or some or one of them between the Reverend Henry Edwards Collins, Rector or Incumbent of the Rectory of the said Parish of Rotherfield, of the first part, the Most Honourable Henry Gilbert Ralph Nevill, Marquis of Abergavenny, the Patron of the said Rectory of Rotherfield, of the second part, the Right Reverend George, Bishop of Chichester, the Ordinary of the said Rectory of Rotherfield, of the third part, and us, the said Ecclesiastical Commissioners, of the fourth part (which Deed is intended to be registered in the books of the Charity Commissioners), the said Henry Edwards Collins did, with the consent of the said Henry Gilbert Ralph Nevill, Marquis of Abergavenny, as such Patron as aforesaid, and of the said George, Bishop of Chichester, as such Ordinary as aforesaid, grant and confirm unto the Minister or Incumbent of the District or New Parish hereinafter recommended to be constituted, and to his successors, one perpetual clear yearly rent charge or net annual sum of £200 to be payable quarterly on the 1st day of February, the 1st day of May, the 1st day of August and the 1st day of November in every year free from and clear of all deductions, taxes, charges, rates, assessments and outgoings whatsoever (except on account of the tax on income or property, if any), and to be for ever issuing and payable out of and charged upon all that the said Rectory of the Parish of Rotherfield and the tithes or tithe commutation rent charges, glebe lands and hereditaments, and all other the endowments and emoluments for the time being to the said Rectory belonging, the first of such quarterly payments in respect of the said clear yearly rent charge or net annual sum of £200 to be made on such of the said quarterly days of payment as shall happen

next after the date of the licence of the first Minister or Incumbent of the said intended District or New Parish and to be a proportionate part of the said quarterly payment calculated from the date of the said licence to the said quarterly day of payment:

“ And whereas the said yearly rent charge or net annual sum of £200 has been granted by the said Henry Edwards Collins as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) the whole right of Patronage of the said proposed District or New Parish and the nomination of the Minister or Incumbent thereof should be assigned in the manner which is hereinafter set forth:

“ And whereas the said Henry Edwards Collins has nominated to us the Bishop for the time being of the said Diocese of Chichester as the person to whom he desires that the whole right of Patronage of the said proposed District or New Parish should be assigned:

“ Now, therefore, with the consent of the said George, Bishop of Chichester (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all that part of the said Parish of Rotherfield which is described in the Schedule hereunder written, all which part together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid become and be constituted a separate District or New Parish for spiritual purposes and that the same shall be named ‘ The New Parish of Saint Michael, Jarvis Brook ’.

“ And we further recommend and propose that the said Church of Saint Michael and All Angels, Jarvis Brook, shall as from the day last mentioned be, and for that purpose we hereby specify the same Church as, the Parish Church of the said New Parish of Saint Michael, Jarvis Brook.

“ And we further recommend and propose that the whole right of Patronage of the said proposed District or New Parish and the nomination of the Minister or Incumbent thereof shall without any assurance in the law other than this Scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be absolutely vested in and shall and may from time to time be exercised by the said George, Bishop of Chichester, and his successors for ever.

“ And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.
