Situations filled by persons who, after nomination for establishment following a period of unestablished or other qualifying service, have been refused establishment on medical grounds and have been permitted by the authorities of their Department, with the approval of the Treasury, to enter or continue in employment in an unestablished capacity with the conditions of service of the established class save in the matter of superannuation and sick leave.

**NATIONAL HEALTH INSURANCE ACTS,
1924 to 1932.**

LAND DRAINAGE ACT, 1930.

RIVER DEE CATCHMENT BOARD.

*River Dee (Upper, Middle and Lower Levels)
Internal Drainage Districts.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the Order made on the 7th April, 1934, in relation to the Scheme prepared by the Dee Catchment Board, under Section 4 (1) (b) of the Act, for the constitution of the River Dee (Upper, Middle and Lower Levels) Internal Drainage Districts.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

**ROMNEY AND DENGEL MARSH MAIN DRAINS
CATCHMENT BOARD.**
