RURAL DISTRICT COUNCIL OF THRAPSTON.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an Order dated the third day of May, 1934, the Minister of Health has Declared that, on and after the twenty-first day of May, 1934, the following provisions of the Public

Health Acts Amendment Act, 1907, shall be in force in the Rural District of Thrapston, namely:—

(a) In the contributory places of Aldwinkle Saint Peters, Brigstock, Chelveston cum Caldecot, Clapton, Denford, Great Addington, Hargrave, Islip, Little Addington, Luffwick or Lowick, Ringstead, Slip-ton, Stanwick, Sudborough, Thrapston, Titchmarsh, Twywell, and Woodford:—

Section 25 comprised in Part II (streets and buildings); and

Sections 34 to 38 (inclusive) and 44 to 46 (inclusive) comprised in Part III (sanitary provisions).

(b) In the contributory places of Brigstock, Islip, Luffwick or Lowick, Thrapston, and Woodford:—

Sections 39 to 42 (inclusive) comprised in Part III (sanitary provisions):

The above provisions are declared to be in force subject, as regards Section 25 of Part II and Sections 35 and 38 of Part III to the conditions specified in the Order.
