LAND DRAINAGE ACT, 1930.

RIVER OUSE (YORKS.) CATCHMENT BOARD.

*Thornton Internal Drainage District.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the Order made on the 26th March, 1934, in relation to the Scheme prepared by the River Ouse (Yorks.) Catchment Board, under Section 4 (1) (b) of the Act, for the constitution of the Thornton Internal Drainage District.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

LAND DRAINAGE ACT, 1930.

RIVER GREAT OUSE CATCHMENT BOARD.

*East of the Ouse, Polver and Nar Internal Drainage District.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a scheme submitted to him by the River Great Ouse Catchment Board under Section 4 (1) (b) of that Act, making provision for the abolition of the Nar Valley and the Wormegay Polver Drainage Districts, the constitution of the East of the Ouse, Polver and Nar Internal Drainage District, and for matters supplemental thereto: and that the Order will become final and have effect as an Act of Parliament, unless within thirty days from the date of this notice a Memorial that the Order shall not become law without confirmation by Parliament is presented to the Minister by some person or body affected by the Order, and having an interest sufficient for the presentation of a Memorial.
