MABLETHORPE AND SUTTON GAS.

(Application for an Order under Section 1 of the Gas Undertakings Act 1929.)

NOTICE is hereby given that the Mablethorpe and Sutton Gas Company Limited (hereinafter referred to as "the Company") whose registered office is at Nos. 22 and 23, Byram Arcade, Station Street, Huddersfield, in the County of York, intend to apply to the Board of Trade for an Order under Section 1 of the Gas Undertakings Act 1929 for the following purposes, that is to say:

1. To authorise the Company to raise Twenty thousand pounds further additional capital by the creation and issue of ordinary or preference shares or by either of these modes.

2. To authorise the Company to borrow on mortgage of their gas undertaking or by the creation and issue of debentures or debenture stock any amount not exceeding seventy-five per centum of such further additional capital.
