

of the Rules Publication Act, 1893, made the undermentioned Regulations:—

- (1) The Traffic Signs (Pedestrian Crossings) Provisional Regulations, 1934, which came into force on the 7th June, 1934.
- (2) The London Traffic (Pedestrian Crossing Places) Provisional Regulations, 1934, which came into force on the 11th June, 1934.

These Provisional Regulations are to continue in force until Statutory Rules have been made in accordance with the last-mentioned Act. The first-mentioned Regulations prescribe the signs to be used in connection with crossing places for pedestrians within 150 feet of a road junction, appointed after 7th June, 1934, and provide that the Traffic Signs (Size, Colour and Type) Provisional Regulations, 1933, shall cease to apply in so far as any such crossing place is concerned. The last-named Regulations provide for certain obligations being imposed on drivers of vehicles and pedestrians at pedestrian crossing places within the London Traffic Area indicated by the traffic signs prescribed by the Traffic Signs (Pedestrian Crossings) Provisional Regulations, 1934.
