LLANGOLLEN URBAN DISTRICT COUNCIL.

WATER SUPPLIES (EXCEPTIONAL SHORTAGE ORDERS) ACT, 1934.

NOTICE is hereby given that the Urban District Council for the Urban District of Llangollen in the county of Denbigh have made an application to the Minister of Health to make an Order under the above Act, authorising the said Council to take water from the River Dee above the Horseshoe Falls at Berwyn in the Parish of Llangollen Rural in the County of Denbigh and to pump same to their present Waterworks in the Vivod Valley during emergencies.

The Maximum quantity of water proposed to be taken by the Council will be Seventy-two thousand gallons each day, and will be drawn off by the Council over a period of eight consecutive hours in each day at the rate of Nine thousand gallons per hour.

CITY OF LEEDS.

HUNSLET (TEMPLENEWSAM) TOWN PLANNING SCHEME AMENDMENT (No. 2) SCHEME.

NOTICE is hereby given that (1) on the 6th day of June, 1934, the Leeds City Council passed a resolution deciding to prepare a Varying Scheme to be known as the Hunslet (Templenewsam) Town Planning Scheme Amendment (No. 2) Scheme with reference to the area of the Hunslet (Templenewsam) Town Planning Scheme as shown on the Map referred to therein; (2) the Map defining the area to which the resolution applies has been deposited at the City Engineer's Office (Town Planning Department), Civic Hall, Portland Crescent, Leeds, and will be open for inspection by all persons interested without charge between the hours of 8.30 a.m. and 12.30 p.m. on Saturdays, and 9 a.m. and 5 p.m. on all other weekdays; (3) any person who is, or claims to be, an owner of any property in the area and any association representing owners of property within the City of Leeds and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the Leeds City Council to register without charge his or their name and address for the service of subsequent notices relating to the scheme.

Under the Town and Country Planning (General Interim Development) Order, 1933,* the development of land in the area during the preparation of the scheme is permitted to the extent specified in the Order and in addition the Leeds City Council are empowered to permit other development in the area during this period, with a view in either case to protecting the development from the risk of removal or alteration without compensation under the scheme when approved and in operation. A print of the Order has been deposited together with the aforesaid Map.

The Leeds City Council intend to proceed as soon as may be with the preparation of a Draft Scheme and any suggestions as to the proposals to be included in the Draft Scheme should be sent in writing to me, the undersigned, Town Clerk and Clerk to the Council.
