

us for the spiritual benefit of the Parish of Stalmine, in the County of Lancaster, and in the Diocese of Blackburn, and now specifically appropriated for the endowment of the New Parish and Vicarage (hereinafter called the Benefice) of Saint Oswald, Preesall, which has recently been formed out of the said Parish of Stalmine, do hereby in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, chapter one hundred and eleven, section five, Grant out of the Common Fund under our control to the Incumbent for the time being of the said Benefice of Saint Oswald, Preesall, and to his successors Incumbents of the same Benefice, all and singular, one yearly sum or stipend of one hundred and twenty-two pounds sixteen shillings and eight pence, such yearly sum or stipend to be calculated from the thirtieth day of March in the year one thousand nine hundred and thirty-four, and to be payable in equal quarterly portions on the first day of February, the first day of May, the first day of August and the first day of November in each and every year: Provided always that the yearly sum or stipend hereby granted shall be and shall be taken to be in lieu of and in full substitution for the yearly sums or stipends aggregating a like amount heretofore payable by us towards the stipend of the Curate serving the Conventional District of Preesall, in the said Parish of Stalmine, under the authority of various Instruments which have been sealed by us and published in the London Gazette: Provided also that if at any time lands, tithes or other hereditaments sufficient in our opinion to produce the said yearly sum or stipend of one hundred and twenty-two pounds sixteen shillings and eightpence or any part thereof, shall be annexed by us to the said Benefice in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of the yearly sum or stipend or of such part thereof as the case may be, shall thereupon and thereafter cease and determine.

#### BISHOP'S STORTFORD GAS.

(Application for Special Order under the Gas Undertakings Acts 1920 and 1929.)

**T**HE Bishop's Stortford Harlow and Epping Gas and Electricity Company (hereinafter called "the Company") whose head office is at Northmet House, Southgate, in the County of Middlesex, are applying to the Board of Trade for a Special Order under the Gas Undertakings Acts 1920 and 1929 for all or some of the following objects:—

1. To change the name of the Company to "Bishop's Stortford Epping and District Gas Company".
2. To make further provision with respect to the issue of stock of the Company by auction

or tender, the offering of stock for subscription and the payment of commission on sale of stock.

3. To make provision with respect to the proportionate payment of dividends on different classes of capital in certain cases and with respect to the application of profits.

4. To make provision with respect to the closing of transfer books, the powers of directors and of committees of directors, special services performed by and remuneration of directors and quorum of directors.

5. To make provision with respect to notices of meetings of the Company and with respect to the register of shareholders and shareholders' address book.

6. To confer further powers of entry upon the Company and to make provision with regard to the retention, use, sale, lease or other disposal of lands belonging to the Company.

7. To confer upon the Company all or any powers commonly conferred on gas undertakers and not hereinbefore referred to and to enact all such provisions as may be deemed expedient for effecting the purposes of the Order.

8. To incorporate with the intended Order the provisions of the Lands Clauses Acts, the Gasworks Clauses Acts 1847 and 1871 and the Companies Clauses Acts 1845 to 1889 with modifications and exceptions and to exempt the Company from some of the provisions of those Acts, to provide that the provisions of the Lands Clauses Consolidation Act 1845 or some or any of them shall not apply to any of the lands which have been or may hereafter be acquired by the Company, and to amend or repeal any provisions of the Bishop's Stortford Gas Act and Orders 1910 to 1928 and of any other Act or Order relating to the matters aforesaid so far as it affects the Company.

Any local or other public authority, company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1. and dispatched on or before the 20th day of July, 1934. Any such objection must state (a) the specific grounds of objection and (b) the omissions, additions or modifications asked for, and a copy thereof must at the same time be forwarded to the under-mentioned Solicitors or Parliamentary Agents.

A copy of the draft Order has been deposited for public inspection at the office of the Company at 45-47, South Street, Bishop's Stortford, at the office of the Clerk of the Peace for the County of Essex at Shire Hall, Chelmsford, and at the office of the Clerk of the Peace for the County of Hertford at 24, Castle Street, Hertford.
