and be annexed for ecclesiastical purposes to the adjoining Parish of Normanton.

"That the said area coloured pink on the said plan marked 'C' and now belonging to the Parish of Penistone may be advantageously separated from that Parish and be annexed for ecclesiastical purposes to the adjoining Parish of Thurgoland.

"That I, the said Bishop of Wakefield, am the Patron of the said Parish of Penistone and the Reverend Edward Barrington Carleton is

the present Vicar thereof.

"That John Montague Spencer Stanhope of Cannon Hall Barnsley is the Patron of the Benefice of Hoylandswaine and the Reverend Herbert Lionel Pratt is the present Vicar thereof.

"That the Master, Fellows and Scholars of Trinity College Cambridge are the Patrons of the said Benefice of Normanton and the Reverend Harold William Orgill is the present Vicar thereof.

"That the Dean and Chapter of the Cathedral Church of Christ in Oxford are the Patrons of the said Benefice of Featherstone and the Reverend James Gray is the present Vicar thereof.

"That the Reverend Charles Henry Archbould Bagshaw, Vicar of Silkstone, is the Patron of the said Benefice of Thurgoland in right of his said Vicarage and the Reverend Estyn St. Clair Millington Collins is the present Vicar thereof, and they all respectively consent to this representation and the scheme hereinafter set forth.

"That pursuant to the direction of the first mentioned Act of Parliament I have drawn up a Scheme in writing appended to this Representation describing the mode in which it appears to me that the separation and annexation before proposed may be best effected and how the changes consequent thereon in respect to ecclesiastical jurisdiction Glebe lands tithes dues rates and payments and in respect to Patronage and rights to pews may be made with justice to all parties interested."

And whereas the said Scheme drawn up by the said Bishop and the Consents referred to in the said Representation are as follows:—

"SCHEME.

"It is proposed that the said portion of the said Parish of Hoylandswaine coloured pink before mentioned on the plan marked 'A' hereto annexed shall be separated from the Parish of Hoylandswaine to which it now belongs and be transferred for ecclesiastical purposes to the adjoining Parish of Penistone.

"That the area coloured pink on the plan marked 'B' hereto annexed now belonging to the said Parish of Featherstone shall be separated from that Parish and be annexed for ecclesiastical purposes to the adjoining Parish of Normanton.

"That that part of the Parish of Penistone which is coloured pink on the plan marked 'C' hereto annexed shall be separated from that Parish and shall be annexed for ecclesiastical purposes to the adjoining Parish of Thurgoland.

"That no change shall be made by this Scheme in respect to the Glebe lands, tithe rent charges or other endowments or emoluments of any of the said Benefices.

"That there shall be no change in the Patronage of any of the said Benefices.

"That the Parishioners of the said portions of the Parishes so transferred as aforesaid shall from the time of separation and annexation be exonerated from all liability for repair of the Parish Churches to which the said portions now belong and shall be liable for the repair of the Parish Churches to which the same are intended to be annexed as aforesaid subject to the provisions of the Compulsory Church Rates Abolition Act 1868.

"That the Parishioners of the portions so separated and annexed shall not after the same have been duly annexed to the aforementioned Parishes be entitled to accommodation in the said Parish Churches and Churchyards from which they have been separated but they shall be entitled to accommodation in the Parish Churches and Churchyards to which they have been annexed.

"That all fees and payments for Burials Baptisms Churchings and Marriages performed by the Incumbents of the Parishes to which the above portions are intended to be annexed as aforesaid and all other ecclesiastical dues and emoluments arising in respect to the said separate and annexed portions and usually paid and payable to the Incumbent of a Benefice shall henceforth be received by the Incumbent of the Parish to which the same are intended to be annexed.
