(34 & 35 VICT., CAP. 12.)

STOURBRIDGE FAIR.

Whereas a representation was made to me as Secretary of State for the Home Department by the Cambridge Borough Council that a Fair has been annually held at Stourbridge or Sturbridge, Cambridge, which by Letters Patent dated the 15th August, 1589, was to commence in each year on the Feast of St. Bartholomew the Apostle (i.e. the 24th August) and last from the same Feast continuously until the 14th day next after the Feast of the Exaltation of the Holy Cross (i.e. the 14th September) and by Order of the Secretary of State dated the 25th day of November, 1927, was restricted to three days, i.e. the 25th, 26th and 27th September; and that it would be for the convenience and advantage of the Public that such Fair should be abolished:

And whereas notice of the said representation and of the time when the same should be taken into consideration has been duly published in pursuance of the Fairs Act, 1871:

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the Public that the said Fair should be abolished :

Now therefore I, as Secretary of State for the Home Department, in exercise of the powers vested in me by the Fairs Act, 1871, do hereby order that the aforesaid Fair which has been anually held at Stourbridge, or Sturbridge, Cambridge, on the dates specified above shall be abolished.
