## MERCHANDISE MARKS ACT, 1926.

In accordance with the provisions of Section 2, sub-section 4 of the Merchandise Marks Act, 1926, the Board of Trade give notice that, in pursuance of applications received by them for the making of Orders-in-Councils to require imported goods of certain classes and descriptions to bear an indication of origin, they have made references to the Standing Committee appointed by them under the Act in respect of imported goods of the following classes and descriptions:--

A.—Articles of the following descriptions made [except where otherwise stated] wholly or partly of metal and metal parts thereof:—

(1) Jewellery and imitation jewellery.

- (2) Mesh hand bags and purses.
- (3) Metal thimbles for sewing.
- (4) Ladies' ornamental belts and girdles wholly of metal, and ornamental metal fittings for ladies' belts and girdles.
- girdles.(5) Vanity and compact cases; cosmetic boxes and containers.
- (6) Mounts for toilet mirrors, brushes and combs.
- (7) Collar and shirt studs, cuff links and tie clips, other than jewellery and imitation jewellery.

B.—Salt.

Attention is called to the fact that, while under the provisions of the above Act, the Committee must in every case referred to them consider whether the goods should bear an indication of origin at the time of sale or exposure for sale, they may also, at their discretion, consider and report upon the question whether such goods should bear an indication of origin at the time of importation.

In connection with the reference in respect of imported salt, the following Declaration has been made by the Board of Trade :--

Declaration, dated July 14th, 1934, made by the Board of Trade, with the concurrence of the Minister of Agriculture and Fisheries, under Section 10 (1) of the Merchandise Marks Act, 1926 (16 & 17 Geo. 5. c. 53).

Whereas by subsection (1) of Section 10 of the Merchandise Marks Act, 1926 (16 & 17 Geo. 5. c. 53) it is provided, that for the purposes of the said Act, unless the context otherwise requires, the expression "agricultural and horticultural produce and the produce of any fishing industry" includes all foodstuffs other than such foodstuffs as the Board of Trade (hereinafter called "The Board") with the concurrence of the Minister of Agriculture and Fisheries may declare not to be foodstuffs for the purposes of that definition:

And whereas the Minister of Agriculture and Fisheries has concurred in a proposal of the Board to declare edible salt not to be a foodstuff for the purposes of the said definition:

Now, therefore, the Board, with the concurrence of the Minister of Agriculture and Fisheries, hereby declare edible salt not to be a foodstuff for the purposes of the aforesaid definition.
