

NOTICE.

The Lords Commissioners of His Majesty's Treasury hereby announce that by a Minute dated the 15th August, 1934, They have prescribed for the purposes of the undermentioned enactments a rate of interest of five per cent. per annum as the maximum rate of interest or dividend on share or loan capital issued by Public Utility Societies, Companies, etc., on any date after the 15th August, 1934, until further notice, viz. :—

(1) Section 90 (5) (a) of the Housing Act, 1925, and section 73 (5) (a) of the Housing (Scotland) Act, 1925;

(2) Section 135 of the Housing Act, 1925, and section 119 of the Housing (Scotland) Act, 1925;

(3) Section 3 (2) of the Housing Act, 1923.

They have also by another Minute of the same date prescribed the rate of five per cent. per annum for the purpose of the definition of "Companies and Private Persons limiting their profits to the rate for the time being prescribed" under Heading I (3) of Their Minute of the 13th March, 1934, which lays down the rates of interest to be charged on loans advanced from the Local Loans Fund on and after that date.
