RURAL DISTRICT OF SETTLE.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

By an Order dated the 1st day of August, 1934, the Minister of Health has declared that, on and after the 23rd day of August, 1934, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the whole or certain portions of the Rural District of Settle, namely:—

(a) In the several contributory places within the district:—

Sections 16, 23, 25, 30 and 33 comprised in Part II (streets and buildings);

Sections 34, 35, 38 and 44 to 46 (inclusive) comprised in Part III (sanitary provisions); and

Part IV (infectious diseases).

(b) In the contributory places of Airton, Austwick, Bentham, Burton in Lonsdale, Clapham with Newby, Giggleswick, Helli-field, Ingleton, Langcliffe, Lawkland, Long Preston, Malham, Rathmell, and Settle:—

Section 27 comprised in Part II (streets and buildings).

(c) In the contributory places of Bentham, Giggleswick, Ingleton, Langcliffe, and Settle:—

Section 48 comprised in Part III (sanitary provisions).
