And I also direct, as from the same date, that it shall not be lawful for the said Alexander Gordon Bonnyman to give prescriptions for the purposes of the Dangerous Drugs (Consolidation) Regulations, 1928.

CHILDREN & YOUNG PERSONS ACT,

THE MAGDALEN HOSPITAL, STREATHAM.
