heavy motor car (as respectively defined in Section 2 of the Road Traffic Act, 1930, or in any regulations made or to be made thereunder) or any motor car (as defined as aforesaid) with seats for more than seven persons exclusive of the driver on the roads known as Bronson Road, Chestnut Road, Dorien Road, Dupont Road, Sydney Road (hereinafter referred to as the "said roads").

2. Nothing in the Order shall prevent the driving upon the said roads at any time of-

(i) any vehicle which is being used for the conveyance of goods or merchandise to or from any house, building or other premises situate on or adjacent to the said roads;

(ii) any vehicle which is being used in connection with the maintenance, improvement or reconstruction of the said roads, or the laying, alteration or repair in or near to the said roads of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity, or any telegraph or telephone wires, cables, posts or supports.
