#### PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF MALE WORKERS.

In accordance with Regulations made by the Minister of Labour under Section 18 of the Trade Boards Act, 1909, and dated 21st April, 1927, the Cutlery Trade Board (Great Britain) HEREBY GIVE NOTICE that they PROPOSE TO VARY Minimum Rates of Wages for Certain Classes of Male Workers set out in their Notices C.T. (7) and C.T. (9) dated 10th August, 1934 and 29th September, 1934 respectively.

Particulars of the proposed variations may be obtained on application to the Secretary of the Trade Board at the address given below.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will CONSIDER ANY OBJECTIONS to the above Proposal to Vary which may be lodged with them within two months from the 28th September, 1934.
