FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1934 (No. 12).

SUBJECT.

Contraction of the Lancashire Foot-and-Mouth Disease Infected Area. Substitutes as from the 5th October, 1934, the following Area for the Infected Area described in the Foot-and-Mouth Disease (Infected Areas) Order of 1934 (No. 10).

An Area comprising:—

In the county of the West Riding of Yorkshire.

The borough of Todmorden.

In the county of Lancaster.

The boroughs of Bacup and Rawtenstall, so much of the borough of Haslingden as lies to the East of the railway line running from Accrington to Ramsbottom, and so much of the county borough of Rochdale and of the borough of Heywood as comprises the former parish of Norden.

The parishes of Cliviger, Habbergham Eaves, Dunnockshaw including its detached part, Whitworth and Wardle, and so much of the parish of Ramsbottom as lies to the East of the road running from Haslingden via Edenfield and Norden to Rochdale.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1934 (No. 13).

SUBJECT.

Contracts the Flintshire Foot-and-Mouth Disease Infected Area, as from the 5th October, 1934, to an area of 2 miles as described in the Schedule, and then releases that area as from the 12th October, 1934.

SCHEDULE.

Contracted Infected Area.

An Area comprising:—

In the county of Flint.

So much of the Petty Sessional Division of Prestatyn as lies to the North of the following boundary:—

Commencing on the River Dee Side of Llynegar footbridge crossing the London Midland and Scottish Railway line at Ffynon Groew, thence across the bridge and across the Chester—Rhyl coast road, and along the Llynegar Hill Road to Penyffordd, thence along the road via Rhewl to Glan-yr-Afon cross-roads, thence in a southerly direction along the road to Afon Goch cross-roads, thence in a westerly direction along the road through Axton Village to Newmarket, thence along the Newmarket—Dyserth road to Mia Hall, and thence along the bye road past Mia Hall and Allt-y-Graig to the four cross roads at Allt-y-Graig, thence north along the Rhuddlan—Prestatyn road as far as the Red Lion Inn, Meliden, thence in a north-westerly direction along the bye road through Penrhwylyfa across the Rhyl—Prestatyn coast road past the

Warrington Children's Camp and on to the foreshore.
