Notice is hereby given, in pursuance of Section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made the following Orders:—

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1934 (No. 19).

SUBJECT.

Declares the area described in the Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

SCHEDULE.

An Area comprising:—

In the county of Lincoln (Parts of Lindsey).

The city and county borough of Lincoln (including Lincoln Castle).

The petty sessional divisions of Brigg, Caistor, Gainsborough, Lincoln (Lindsey), Market Rasen (except the parish of Binbrook), Wragby (except the parishes of Ludford Magna, Burgh on Bain, South Willingham, Benniworth, Panton, Sotby, Hatton, Langton by Wragby, Stainfield, Bardney and Tupholme), Epworth (except the parishes of Garthorpe, Luddington, Amcotts, Eastoft, Crowle and Wroot), Scunthorpe (except the parishes of Whitton, Winteringham, Winterton, Alkborough, West Halton and Burton upon Stather).

The parishes of Saxby All Saints and Bonby.

In the county of Lincoln (Parts of Kesteven).

"The parishes of Canwick, Washingborough, Skellingthorpe and Doddington and Whisby.

In the county of Nottingham.

The parishes of West Stockwith, Misterton, Gringley on the Hill, Walkeringham, Beckingham, Saundby, Bole, North Wheatley, West Burton, South Wheatley, Sturton le Steeple,
