THE BANBURY WATER COMPANY (WATER SUPPLIES EXCEPTIONAL SHORTAGE) ORDER, 1934.

NOTICE is hereby given that the Minister of Health, on the application of the Banbury Water Company and in exercise of his powers under the above mentioned Act has issued an Order No. 80,058 and dated 22nd October, 1934, authorising the Banbury Water Company (subject to certain provisos and regulations in the said Order set out)—

(a) to regulate certain sluices on the River Cherwell,

(b) to take water from the Oxford Canal,

(c) to take water from the lake of Edgcote Park,

(d) to enter upon, occupy and use the lands specified in the Schedule to the said Order,

(e) to prohibit the use of water for certain purposes.

ELEVENTH SCHEDULE.

1934 REVIEW OF THE OPERATION OF THE RAILWAY FREIGHT REBATES SCHEME AND APPLICATION IN RESPECT OF ADMINISTRATIVE EXPENSES.

NOTICE is hereby given that the Railway Rates Tribunal will sit at 10.30 a.m. on Monday, the 19th November, 1934, in Court "A," Judges' Quadrangle, Royal Courts of Justice, London, W.C.2, to review the operation of the Railway Freight Rebates Scheme for the year ending 30th September, 1934, pursuant to the provisions of Part 1 of the Eleventh Schedule to the Local Government Act, 1929.

Notice is also given that the Railway Companies to which the said Scheme applies have filed with the Tribunal an Application (1934 No. 156) pursuant to the provisions of subparagraph 1 (a) of paragraph 5 of the said Part 1 of the Eleventh Schedule that in respect of the year 1st October, 1934, to 30th September, 1935, the sum to be paid out of the general monies of the Railway Freight Rebates Fund in respect of administrative expenses shall be increased from one-half of one per cent. to one and one-tenth per cent. or such other percentage of the aggregate of the estimated rate relief of the said Companies in that year as will yield a sum amounting to approximately £43,000; which Application will also be heard at the above-mentioned time and place.

Notice is further given that Accounts and Statements relative to such Review have been

lodged with the Tribunal. Such Accounts and Statements and the aforesaid Application may be inspected at the Office of the Registrar, 2, Clement's Inn, London, W.C.2, at any time during office hours. Copies of the said Accounts and Statements may be obtained (price 2s. 6d. post free) on prepayment, from the Secretary, the Railway Clearing House, Euston Square, London, N.W.1.

Any Railway Company to which the said Scheme applies or Representative Body of Traders Interested, which may be desirous of being heard before the Tribunal on the Review must file a Notice of such desire, and any person desiring to object to the aforesaid Application must file a separate Notice of Objection at the Office of the Registrar, 2, Clement's Inn, London, W.C.2, on or before Friday, the 9th day of November, 1934.

Such Notices must be on foolscap size paper and must state concisely the Submission (if any) which is desired to be made, and in the case of an Objection, the nature and grounds thereof. A Notice by a Representative Body of Traders must in addition contain a statement of the facts upon which such Body claims to represent a substantial number of persons interested in any or all of the selected traffics.

Each Notice filed must be stamped with an adhesive fee stamp for 2s. 6d. (which can be purchased at the office of the Tribunal only). If sent by post each Notice must be accompanied by a Postal Order for 2s. 6d. payable to the Registrar, Railway Rates Tribunal, when a stamp will affixed at the office. Five additional copies of each Notice must be lodged with the original at the office of the Registrar.

WELLINGTON AND DISTRICT TOWN PLANNING SCHEME.

NOTICE is hereby given that (1) on the seventeenth day of October, 1934, the Minister of Health notified his approval of the resolution of the Wellington Urban District Council, dated the seventh day of August, 1934, deciding to prepare the above planning scheme with reference to an area situate wholly within and comprising the Urban District of Wellington, the Rural District of Wellington, and partly within the Rural District of Taunton. (2) A certified copy of the map defining the area to which the resolution applies has been deposited at the Surveyor's Office, 67, High Street, Wellington, Somerset, and will be open for inspection by all persons interested without charge between the hours of 9.30 a.m. to 1 p.m. and 2 p.m. to 5 p.m. on Mondays to Fridays, and 9.30 a.m. to 1 p.m. on Saturdays. (3) Any person who is, or claims to be, an owner of any property in the area and any association representing owners of property within the said area and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the Wellington Urban District Council to register without charge his or their name and address for the service of subsequent notices relating to the scheme.
