SUBJECT.

Declares the Area shown in the Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

SCHEDULE.

An Area comprising:—

*In the county of Devon.*

The city and county borough of Exeter.

The boroughs of Torquay and Totnes.

The petty sessional divisions of Wonford including its detached parts, Woodbury, Teignbridge, Paignton, and Crockernwell (*except the parishes of Throwleigh and Gidleigh*).

The parishes of Shobrooke, Upton Hellions, Crediton Town, Crediton Hamlets, Newton St. Cyres, Colebrooke, Clannaborough, Rockbeare, Aylesbeare, Venn Ottery, Harpford, Newton Poppleford, Berry Pomeroy, Littlehempston, Ashprington, Harberton, Dartington, Rattery, South Brent, Dean Prior, East Buckfastleigh, West Buckfastleigh, Cornworthy, and Dittisham.

LAND DRAINAGE ACT, 1930.

RIVER RODING CATCHMENT BOARD.

*East Ham and Ilford Bridge to Ongar and Canfield Internal Drainage Districts.*

Notice is hereby given that the Minister of Agriculture and Fisheries, in exercise of the powers conferred upon him under Section 4 (3) of the Land Drainage Act, 1930, proposes to make an Order confirming a scheme submitted to him by the River Roding Catchment Board under Section 4 (1) (b) of the Act, making provision for the constitution of two Internal Drainage Districts, to be known as the East Ham Internal Drainage District and the Ilford Bridge to Ongar and Canfield Internal Drainage District, the abrogation of the powers of the Havering and other Levels Commissioners of Sewers and certain of the powers of the West Ham Corporation within the East Ham Internal Drainage District, the abolition of the West Ham Drainage District within the River Roding Catchment Area, and certain matters supplemental thereto.
