The Civil Service Commissioners hereby give notice that an Open Competitive Examination for the situations of Typist and Clerk-Typist in Departments of the Civil Service will be held in Belfast, Birmingham, Bristol, Cardiff, Edinburgh, Glasgow, Leeds, Liverpool, London, Manchester, Newcastle-on-Tyne and Portsmouth, commencing on the 19th March, 1935, under the Regulations dated the 11th November, 1927, and published in the London Gazette of the same date. No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received on or before the 10th January, 1935, an application, in the Candidate's own handwriting, on the prescribed form, which may be obtained from the Secretary at once.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz. :--

REGULATIONS RESPECTING TWO SPECIAL QUALIFY-ING EXAMINATIONS FOR THE SITUATIONS OF TYPIST AND CLERK-TYPIST IN DEPARTMENTS OF THE CIVIL SERVICE.

1. Candidates must have been serving in a British Government Department on or before the 24th August, 1932, and also on the 1st August, 1934, in one of the following capacities, viz.:—Temporary Typist; Temporary Clerk-Typist; Temporary 'Shorthand-Typist; Temporary Clerk-Shorthand-Typist; Temporary Duplicator Operator in His Majesty's Stationery Office.

2. There will be no age limits for admission to these examinations, but candidates will not be eligible for appointment in an established capacity on the result of the first examination if they are over 50 years of age on the 1st August, 1934, or on the result of the second examination if they are over 50 years of age on the 1st October, 1935.

3. Candidates must be unmarried or widows, and before they can be appointed in an established capacity they will be required to satisfy the Civil Service Commissioners that they are duly qualified in respect of health and character.

4. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject.

Provided that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a naturalborn British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act. 5.
