## LONDON PASSENGER TRANSPORT BOARD. ..

Explosives Act, 1875.

MOTICE is hereby given: (a) That the London Passenger Transport Board (hereinafter called "the Board") intend under and in pursuance of the Explosives Act, 1875, 38 Vic. Cap. 17, and every other power and authority vested in them to enact similar Byelaws to those in force upon the systems of the Railway Companies operating in England subject to

  - "No explosive shall be brought, sent or forwarded to or conveyed upon any rail-

way of the board: provided that this byelaw shall not apply to the section of the railways of the Board north of and including Finchley Road Station which formerly formed part of the Metropolitan Railway."

- (ii) The extension of the byelaw relating to the conveyance of safety cartridges and percussion caps and safety fuse (for blasting) by passenger train to permit of the conveyance of tracers for line-throwing guns.
