Burgesses of the Borough of Scarborough (hereinafter called "the Corporation") for a Provisional Order (hereinafter called "the Order") pursuant to the provisions of the General Pier and Harbour Act 1861, and the General Pier and Harbour Act 1861, Amendment Act, 1862, for the following purposes or some of them (that is to say):—

1. To re-constitute and appoint the Scarborough Harbour Commissioners, and to provide for the carrying on of the Scarborough Harbour Undertaking by the Commissioners as so reconstituted or appointed, on such terms or with such restrictions as may be contained in the Order; to provide for the appointment and election of the Commissioners as reconstituted by the Order to represent the Corporation, registered shipowners and registered payers of dues, with such number of Life Commissioners as may be specified in the Order; to make all necessary provision for the retirement of the existing Commissioners or some of them and the qualification, appointment, election and retirement of Commissioners, and the filling up of casual vacancies.

2. Subject to the provisions of the Order to provide for cancellation of certain debts of the Commissioners to the Corporation on such conditions and stipulations as may be contained in the Order; to prohibit the Commissioners from borrowing money otherwise than with the consent of the Corporation, or from parting with any of their assets without such consent or otherwise than in accordance with the Order.

3. To provide for the transfer to the Corporation of some or all of the property of the Commissioners, or to vest such property in the Corporation and the Commissioners jointly, or to provide that the property of the Commissioners shall not be disposed of by them except with the consent of the Corporation, or such other consent as may be provided by the Order.

4. To require the Commissioners to submit their annual estimates of revenue and expenditure to the Corporation for the approval of the Corporation, and to prohibit the Commissioners from incurring expenditure except under such conditions as may be prescribed in the Order, or with such consent or authority as may be laid down therein.

5. To confer further powers upon the Corporation with reference to the guaranteeing of loans and other expenditure incurred or to be incurred by the Commissioners, and to authorise the Corporation to contribute to expenses of the Commissioners on revenue account.

6. To alter or amend the qualification of persons entitled to vote in any election of a Commissioner or Commissioners to represent payers of harbour dues.

7. To increase or vary the dues, rates, tolls, and charges prescribed by the Scarborough Harbour Order, 1918, or to repeal wholly or in part the provisions relating to those dues, rates, tolls, and charges and to prescribe new, dues, rates, tolls, and charges with respect to ships, fishing vessels, rowing, motor and other boats and aircraft entering, using or leaving the harbour, vessels passing' through the bridge, pleasure steamers, the use of cranes, weighing machines, and lighthouses, buildings and sheds, passengers, passengers' luggage landed or embarked, and goods shipped, unshipped and transhipped, and in connection

therewith to alter, amend, extend or enlarge some or all of the provisions of the Acts and Orders relating to the Scarborough Harbour undertaking, and any other enactment relating to or affecting the Commissioners, and the making, levying, demanding and taking of dues, rates, tolls and charges and to confer, vary and extinguish exemptions from the payment of dues, rates, tolls and charges.

8. To authorise the Corporation to lease for such period as may be prescribed in the Order or with the consent of the Minister of Transport to sell or otherwise dispose of lands and property transferred to them in pursuance of the Order or otherwise coming into their possession or under their control.

9. To authorise the Commissioners to lease or to make charges for the use of lands and other property belonging to them or under their control and to provide that moneys so received by the Commissioners shall form part of their revenues for the purposes of all or any of the enactments relating to the Commissioners or the harbour undertaking.

sioners or the harbour undertaking. 10. To empower the Commissioners or their harbour master to regulate the use of the harbour by seaplanes and aircraft and to extend to such seaplanes and aircraft some or all of the enactments of the Commissioners relating to vessels.

11. To amend, extend, alter or repeal all or some of the provisions of the Scarborough Harbour Act, 1843, the Scarborough Harbour Act, 1876, the Scarborough Harbour Order, 1918, the Scarborough Corporation Act, 1900, the Scarborough Corporation Act, 1925, and the Scarborough Corporation Act, 1931, and any other Act or Order relating to the Corporation, the Commissioners and the Harbour undertaking.

12. To incorporate with the Order and with the enactments referred to in the last preceding paragraph of this notice all or some of the provisions of the Lands Clauses Acts, the Harbours, Docks and Piers Clauses Act, 1847, the Commissioners Clauses Act, 1847, and any amendment or modification of those Acts.

13. To vary or extinguish all or any rights or privileges which would or might interfere with the objects of the Order, and to confer other rights and privileges.

14. To authorise the Corporation and the Commissioners to borrow money and to provide for the payment by those bodies or either of them of the expenses of or referred to in the Order.

And notice is hereby also given, that on or before the 30th day of November instant a copy of this notice as published in the London Gazette will be deposited for public inspection with the Clerk of the Peace for the North Riding of the County of York, at his office at Northallerton; at the Customs House for the Port of Scarborough, and at the office of the Ministry of Transport, Whitehall Gardens, London.
