The following Statute made by the University of Oxford on the 20th day of November, 1934, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923."

UNIVERSITY OF OXFORD.

STATUTE APPROVED BY CONGREGATION ON
TUESDAY, 20 NOVEMBER, 1934.

Whereas it is expedient to determine the source from which repayments to Colleges under *Statt. Tit. XIX. § 18 cl. 7, 2nd proviso*, should be met:

Now the University of Oxford, in exercise of the powers in that behalf conferred upon it by the *Universities of Oxford and Cambridge Act, 1923*, and of all other powers enabling it, enacts, subject to the approval of His Majesty in Council, as follows:—

1. In *Statt. Tit. XIX. § 19, cl. 3 (Statuta, ed. 1934, p. 343, line 37)*, before the present sub-clause (1) insert "(1) Any payments due to Colleges under *Statt. Tit. XIX. § 18, cl. 7, 2nd proviso*".
2. Renumber the present sub-clauses (1) and (2) as (2) and (3) respectively.
