RULES PUBLICATION ACT, 1893.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport after the expiration of at least 40 days from this date in pursuance of the powers conferred upon him by Section 10 of the aforesaid London Traffic Act to make Regulations in regard to a system of "one-way" traffic working in Hart's Lane, Nettleton Road and Hatcham Park Road, Deptford.

And notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Prescribed Routes) (No. 37) (Hart's Lane, Nettleton Road and Hatcham Park Road, Deptford) Provisional Regulations, 1934, to bring into force the above-mentioned scheme forthwith as Provisional Regulations to continue in force until Statutory Rules have been made in accordance with the provisions of Section 1 of that Act. These Regulations will revoke the London Traffic (Prescribed Routes) (No. 3) Provisional Regulations, 1934.
