SALMON AND FRESHWATER FISHERIES ACT, 1923.

THE LUNE DISTRICT FISHERY ORDER, 1934.

The Minister of Agriculture and Fisheries has made and confirmed the above Order under Part IV of the Salmon and Freshwater Fisheries Act, 1923. The Order provides for (1) the alteration of the yearly value of private fisheries liable to be assessed; (2) the amendment of the rules with respect to the election of members to the Lune Board of Conservators representative of private fisheries; (3) the application of the provisions of Sections 61 to 64 inclusive of the Salmon and Freshwater Fisheries Act, 1923, to all freshwater fish in the Fishery District in like manner as they apply to salmon; and (4) certain other matters.

Notice is hereby given, in pursuance of Section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made the following Orders:—

Order No. 5276.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1934 (No. 58).

SUBJECT.

(1) Further contracts the Devonshire Infected Area, as from the 24th December, 1934, to the area as described in the First Schedule.

(2) Releases the Devonshire Infected Area from Restrictions and revokes Orders Nos. 5248 and 5264 as from the 31st December, 1934.

FIRST SCHEDULE.

Contracted Infected Area.

An Area comprising:—

In the county of Devon.

The parishes of Teignrace and Kingsteignton and such parts of the parishes of Ideford, Chudleigh, Hennock, Bovey Tracey, Ilsington

and Highweek as lies within the following boundaries:—

Commencing at the Ideford-Bishopsteignton parish boundary at Luton Cross and proceeding in a north-westerly direction through the village of Ideford via Longthorn Cottage to the main Kingsteignton-Exeter road by Chudleigh (or Ideford) Arch, thence in a generally northerly direction along the said Kingsteignton-Exeter road as far as Thorn's Cross, thence proceeding in a westerly direction via Kerswell Rock to Kerswell Cross and Crammer's Bridge, and thence to the main Chudleigh-Exeter road at Crammer's Cross—proceeding in a generally westerly direction along Milestone Lane to Milestone Cross and thence via Rattyball Wood, Coombeshead Cross, Coombeshead, Farley, and Farley Hill to Trusham Station. Crossing the River Teign at Crocombe Bridge, and proceeding in a south-westerly direction via Leigh Cross and Warmhill to Five Lanes and thence via Higher Crownley, Lower Crownley and Trough Lane to Bovey Tracey. Proceeding along East Street, and Fore Street, Bovey Tracey, in a southerly direction via St. John's Church to Pottery (or Thorn) Cross, Binney Bridge, Cummings Cross and Halford to the main Plymouth-Exeter road at Blackpool School. Thence proceeding at first north-easterly, and then easterly along the road passing Sandpit Copse and Lower Staplehill to a point at which the said road intersects the Islington-Highweek parish boundary. Thence in a southerly direction along the parish boundary via Eastdown Barn to the main Ashburton-Newton Abbot road at Ingsdon Cross, thence in an easterly direction along the said Ashburton-Newton Abbot road via Mile End Cross, and Mile End Road to Highweek. Proceeding in an easterly direction through Highweek Village, Church Path, via All Saints Church to the Bovey Tracey-Newton Abbot road at Sandford Orleigh, thence in a southerly direction along the Bovey Tracey-Newton Abbot road to Jetty Marsh Road. Proceeding along Jetty Marsh Road and Jetty Marsh Quay to the point at which Jetty Marsh Quay intersects the Teignrace-Highweek parish boundary; thence following the Teignrace-Highweek Parish boundary and the Kingsteignton-Wolborough, Kingsteignton Milber, Kingsteignton-Hacombe with Combe and Kingsteignton-Bishopsteignton parish boundaries to the parish of Ideford, and then following the Ideford-Bishopsteignton Parish boundary to the point of commencement at Luton Cross.
