

day of June, 1934, to sanction revised scales of pay with effect from the 1st day of July, 1934:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to empower us to grant to any such Warrant Officers who have been promoted to Warrant rank between the 1st day of October, 1931, and the 30th day of June, 1934, such special rates of pay as Warrant Officers with effect from the 1st day of July, 1934, as would have been granted to them on promotion had the revised scales of pay sanctioned by Your Order bearing date the 29th day of June, 1934, then been in force and, similarly, to empower us, if and whenever hereafter increased scales of pay are granted solely on account of an improvement in the state of the national finances to the men whose pay was reduced as from the 1st day of October, 1931, to grant, as from the same date to any Warrant Officers then on the list who may have been promoted from such men since the 1st day of October, 1931, special rates of pay of such amount as would have been granted to them had the increased scales of pay been in force on the day preceding their promotion.

"Provided that no officer shall receive a special rate of pay in excess of the rate which would have been granted to him had there been no reduction in the pay of men on the 1st day of October, 1931, on grounds of national economy or in excess of the maximum rate of full pay on the normal scale from time to time applicable to his rank:

"Provided also that, except as expressly provided herein, nothing in this Order shall be taken to alter the conditions prescribed for the grant of special rates of full pay to Warrant Officers in Your Orders in Council bearing dates the 9th day of March, 1921, the 16th day of December, 1925, and the 19th day of May, 1931.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals."

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 6th day of November, 1934 (G.H. 773/34), in the words following, viz.:-

"Whereas by section 20 of the Greenwich Hospital Act, 1865, it is enacted, *inter alia*, that the Admiralty shall from time to time continue or appoint such officers, clerks and servants for the purposes of the Hospital and Schools as seem fit, and may (subject to the

approval of Your Majesty in Council) fix the salaries of such officers and clerks:

"And whereas by section 8 of the Greenwich Hospital Act, 1872, it is enacted that the provisions of section 20 of the Greenwich Hospital Act, 1865, so far as the same relate to salaries, shall extend to pensions and pecuniary benefits of any kind:

"And whereas Mr. Arthur William Smallwood, C.B.E., Director of Greenwich Hospital, retired from the service of Greenwich Hospital on the 12th October, 1934, on account of age:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to authorise the grant to Mr. Smallwood from the funds of Greenwich Hospital of a pension at the rate of Four hundred and sixty-six pounds, five shillings and two pence (£466 5s. 2d.) a year as from the date of his retirement, and an additional allowance of One thousand, three hundred and seventeen pounds, nineteen shillings and three pence (£1,317 19s. 3d.)."

WHEREAS by the Extradition Acts, 1870 (33 & 34 Vict. c. 52) to 1932 (22 & 23 Geo. V. c. 39) it was, amongst other things, enacted that, where an arrangement has been made with any foreign State with respect to the surrender to such State of any fugitive criminals, His Majesty may, by Order in Council, direct that the said Acts shall apply in the case of such foreign State; and that His Majesty may, by the same or any subsequent Order, limit the operation of the Order, and restrict the same to fugitive criminals who are in or suspected of being in the part of His Majesty's dominions specified in the Order, and render the operation thereof subject to such conditions, exceptions and qualifications as may be deemed expedient:

And whereas under the provisions of Article 19 of the Treaty signed on the 11th day of January, 1932, between His Majesty and the President of the Republic of Poland for the mutual extradition of fugitive criminals, the terms whereof were recited in the Poland (Extradition) Order in Council, 1934, and are as follows:-

His Majesty The King of Great Britain, Ireland and the British Dominions beyond the Seas, Emperor of India,
