

within those parts proposed to be transferred and the Incumbents of the Parishes to which they are proposed to be so transferred shall have sole and exclusive cure of souls within the same respectively.

"4. The Inhabitants of the portion of the said two Parishes proposed to be so transferred respectively shall be exonerated from all liability to repair the Parish Churches to which they now belong but shall be liable with the other Inhabitants thereof, subject to the provisions of 'The Compulsory Church Rate Abolition Act 1868,' to the repair of the Parish Churches to which they are proposed to be transferred respectively and they shall have the same rights as to pews and the performance of all Offices and Services of the Church at the Parish Churches to which the said parts are so proposed to be transferred and the Parishes belonging thereto as the other Inhabitants thereof respectively.

"5. The fees for such Offices and Services performed for the Inhabitants of the said portions of the two Parishes proposed to be transferred as aforesaid or arising within the limit of the same and usually payable to the Incumbent of a benefice shall belong to the Incumbents of the Parishes and Benefices to which they are proposed to be transferred as aforesaid respectively.

"6. No alteration shall be made in respect of the Patronage or any Glebe Land, Tithe, Tithe Rentcharge or other Endowments of any kind of either of the said Benefices or Parishes proposed to be affected by this Scheme.

" CONSENTS.

"We, the undersigned, being respectively the Incumbents and the Patrons entitled to present to the Benefice of Drypool, Saint Andrew, and Saint Saviour, Wilmington, affected by the foregoing Representation and Scheme do hereby give this our Consent in writing to the said Representation and Scheme and to the several matters and things therein stated and proposed so far as the same affect our respective Benefices and Parishes estates and interests as such Incumbents and Patrons.
