of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 13th day of December, 1934, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Churches and Cure of Appleton le Street, with the Chapelry of Amotherby annexed (hereinafter called 'the said Benefice of Appleton le Street with Amotherby') in the County of York and in the Diocese of York:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Appleton le Street with Amotherby is vested upon trust for sale in William St. John Fenton Miles, of the Old Bank in the of Bristol, Esquire, Mary Lilian Pretorius, of Number 8, Princes Buildings, Clifton, Bristol aforesaid, married woman, and Henry Thornton Locock, of Number 41, Broad Street, Bristol aforesaid, Solicitor, as trustees of the Will dated the 8th July, 1921, of the late Robert Fenton Miles, the last surviving trustee of a Marriage Settlement dated the 18th January, 1860, the said Advowson being part of the property comprised in such settle-

"And whereas Charles Edmond Cleaver Peach, of the Orchard House, South Cerney, Cirencester, in the County of Gloucester, Esquire, is now the person beneficially and absolutely entitled to the proceeds of sale of

the said Advowson:
"And whereas the said William St. John Fenton Miles, Mary Lilian Pretorius and Henry Thornton Locock, with the consent of the said Charles Edmond Cleaver Peach, are willing that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Appleton le Street with Amotherby should be transferred to and be vested in the Archbishop of York for the time being:

"And whereas the Right Honourable and Most Reverend William, now Archbishop of York, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the hereinbefore mentioned Acts or by some or one of them is made necessary, he, the said William, Archbishop of York, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Appleton le Street with Amotherby which is hereinbefore mentioned and hereinafter recommended and proposed!

will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Appleton le Street with the Chapelry of

Amotherby annexed: "Now, therefore, with the consent of the said William St. John Fenton Miles, Mary Lilian Thornton Locock, Pretorius, Henry Charles Edmond Cleaver Peach (in testimony whereof they have signed and sealed this Scheme), and with the consent of the said William, Archbishop of York (in testimony whereof he has signed this Scheme and sealed the same with his Archiepiscopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Appleton le Street with Amotherby shall be transferred to the said William, Archbishop of York, and his successors in the same Archbishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said William, Archbishop of York, and by his successors in the same Archbishopric for

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of York.
