FALMOUTH.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Falmouth (hereinafter called the Corporation) have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Falmouth Water Act, 1930, as extended and applied to the Corporation by the Falmouth Corporation Water Act, 1930, so as :—

(1) To extend until the thirty-first day of December, 1942, the time limited by Section 7 of the said Falmouth Water Act, 1930, for the completion of the waterworks authorised by that Act to be constructed in the parishes of Budock Rural and Mabe in the rural district of East Kerrier, and comprising an impounding reservoir to be formed by means of a dam across the brook known as the Anter Brook, a new road being a diversion of the existing public road leading from Trenoweth Village to Tresooth, two acqueducts, and subsidiary works.

(2) For the several purposes of the Application or for purposes connected with,
