RULES PUBLICATION ACT, 1893.

ROAD TRAFFIC ACTS, 1930 TO 1934.

The Minister of Transport hereby gives notice under the Rules Publication Act, 1893, that he proposes after the expiry of at least forty days from this date in pursuance of the power conferred upon him by the Road Traffic Acts, 1930 to 1934, to make Regulations relating to the traffic signs which a local authority shall cause to be erected in accordance with the provisions of sub-section (7) of Section 1 of the Road Traffic Act, 1934.
