Order No. 5289.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1935 (No. 1).

Contracts the Wiltshire Foot-and-Mouth Disease Infected Area as from the 11th January, 1935, to the area as described in the Schedule.

SCHEDULE.

Contracted Infected Area.

An Area comprising:—

In the county of Wilts.

The parishes of Marston Meysey, Latton, Castle Eaton, Inglesham, Hannington, Highworth, Stanton Fitzwarren, Blunsdon St. Andrew, Haydon Wick and so much of the parishes of Cricklade and Purton as lies to the north and west of the following boundary, namely:—

Commencing at the point where the Ashton-Keynes-Cricklade parish boundary crosses the road from Ashton Keynes to Chelworth Green near Bournlake Farm; thence along the said road via Chelworth Green and Broadleaze Farm to the point where it meets the Wilts and Berks Canal; thence in a southerly direction following the canal to the point where it crosses the Purton-Haydon parish boundary at the Aqueduct over the river Ray.

In the county of Berks.

So much of the parishes of Buscot and Coleshill as lies to the west of the road running from Lechlade via St. John's Bridge, Broad Leaze Farm and Worsell Farm to Coleshill and to the north of the road from Coleshill to Highworth.

In the county of Gloucester.

The petty sessional division of Fairford (except the parishes of Bibury, Coln St. Aldwin including its detached part, Eastleach Turville, Eastleach Martin and so much of the parish of Hatherop as lies to the north of the road from Coln St. Aldwin to Hatherop).

The parishes of Ampney St. Peter, Driffield and Down Ampney.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1935 (No. 2).

SUBJECT.

Further contracts as from the 13th January, 1935, the Buckinghamshire Foot-and-Mouth

Disease Infected Area to the two areas as described in the First Schedule; releases Area No. 1 from restrictions as from the 19th January, 1935; releases Area No. 2 from restrictions and revokes Orders Nos. 5282 and 5287 as from the 20th January, 1935.

FIRST SCHEDULE.

Contracted Infected Areas.

Areas comprising:—

Area No. 1.

In the county of Buckingham.

The parishes of Longwick cum Ilmer, Kingsley and Aston Sandford, and so much of the parishes of Haddenham, Dinton, Princes Risborough and Bledlow cum Saunderton as lies within the following boundary, namely:—

Commencing at the point where the Thame-Haddenham road crosses the Buckinghamshire county boundary near Clacken Arches; thence following the Thame-Haddenham-Hartwell road to the cross road near Bridgefoot Farm; thence in a south-easterly direction along the Meadle road via Ford to the Dinton-Longwick cum Ilmer parish boundary; thence in a north-easterly direction along the said parish boundary to its junction with the Longwick cum Ilmer-Great and Little Kimble parish boundary; thence in a south-easterly direction along the latter parish boundary to the Great Western and Great Central Joint Railway Line (Aylesbury Branch); thence in a south-westerly direction along the said railway to the junction at Princes Risborough; thence in a westerly and south-westerly direction along the High Wycombe-Watlington Branch Line of the Great Western Railway to the point where the said railway crosses the Oxford-Buckingham county boundary.

In the county of Oxford.

So much of the parishes of Chinnor and Towersey as lies within the following boundary, namely:—

Commencing at the point where the Watlington Branch line of the Great Western Railway crosses the Oxford-Buckingham county boundary near Hempton; thence in a south-westerly direction along the said railway to Chinnor Station; thence in a north-westerly direction along the Chinnor-Thame road via Emmington to the Thame-Towersey parish boundary; thence along the said parish boundary and the Oxford-Buckingham county boundary to the point where the latter boundary crosses the Thame-Haddenham road near Clacken Arches.

Area No. 2.

In the county of Buckingham.

So much of the parishes of Worminghall, Ickford and Shabbington as lies to the south of the road from Wheatley via Townsend and Town's End Cross Roads to Worminghall and of the road from Worminghall via Shabbington to Thame.

In the county of Oxford.

The parishes of Waterstock, Tiddington with Albury, and Great Milton, and so much of the parishes of Thomley, Waterperry, Tetsworth
