In the county of Dorset.

The boroughs of Weymouth and Melcombe

Regis, Dorchester and Bridport.

The petty sessional divisions of Dorchester (except the parish of Melbury Sampford) and Cerne (except the parishes of Wootton Glanville and Pulham).

The parishes of Chaldon Herring, West Lulworth, East Lulworth, Tyneham, Steeple, East Holme, Coombe Keynes, Winfrith Newburgh, Moreton, Wool, East Stoke, Bere Regis, Turners Puddle, Affpuddle, Bloxworth, so much of the parish of Wareham St. Martin as lies to the south and west of the road from Wareham via Wareham Station and Cold Harbour to Stroud Bridge, Winterborne, Kingston, Winterborne Whitchurch, Milborne, Milton Abbas, Hilton, Stoke Wake, so much of the parish of Leigh as lies to the south and west of the road from Chetnole via Leigh and Totnell Corner to Three Gates, Wraxall, Hooke, North Poorton, Mapperton, Power-stock, Loders, Askerswell, Chilcombe, Shipton Gorge, Burton Bradstock, Bothenhampton, Bradpole, Allington, and so much of the parish of Netherbury as lies to the east of the road from Bradpole via Melplash to Beaminster.

PENNINE RANGE (MOVEMENT OF SHEEP) ORDER OF 1935.

Subject.

Contracts the Area No. 1 as described in the First Schedule to the Pennine Range (Movement of Sheep) Order of 1934 so as to comprise the area described in the Schedule to this Order.

SCHEDULE.

So much of the county of the West Riding of Yorkshire as lies within the following

boundary, namely:-

Commencing at the point where the London, Midland and Scottish Railway line from Kirkby Stephen to Hawes Junction passes over the main Garsdale Road north-east of Garsdale Head, thence in a generally southerly direction along the said railway via Hawes Junction, Dent Station, Ribblehead Station, Horton Station, Stainforth and Settle to the

point where it joins the Branch line from Clapham Station; thence in a north-westerly direction along the latter railway via Giggleswick Station to Clapham Station; thence in a westerly direction along the railway via High Bentham Station to the point near Lower Bentham where the railway is carried over the road from Oxenforth Green to Lower Bentham; thence in a northerly direction along the road via Lower Bentham, Wards End, Four Lane Ends, Sunderland House, and Burton-in-Lonsdale to the point where the road crosses the county boundary at Stainderber; thence following the county boundary in a north-easterly direction via Ireby Beck, Ireby Fell and Gragareth to the Stone marking the boundary of the counties of Lancaster, Westmorland and the West Riding of Yorkshire at Blea Gills; thence following the county boundary wall via Crag Hill to the point where it joins the wall enclosing the High Short Gill Allotment; thence along the east side of this wall and the wall enclosing the Short Gill Allotment to the point where it joins the Barbon-Dent road; thence in a south-westerly direction along the latter road to the point where it meets the wall separating the counties of Westmorland and the West Riding of Yorkshire; thence in a generally northerly direction along the said wall via Calf Top, Long Bank and Brown Knott to the point where it meets the eastern wall of Holme Fell; thence along the latter wall to the point where it is crossed by the London, Midland and Scottish Railway line from Sedbergh to Kirkby Lonsdale; thence north along the said railway to Sedbergh Station; thence in a generally easterly direction along the road via Sedbergh to the point where the road forks at Thorns Hall; thence along the road crossing the River Rawthey to Hall Bank; thence following the River Clough through Garsdale and Garsdale Head to the point of commencement.
