LEEDS CORPORATION TRANSPORT DEPARTMENT.

ROAD TRAFFIC ACT, 1930. PART V.

NOTICE is hereby given that the Council of the City and County Borough of Leeds (hereinafter called "the Council") have applied to the Traffic Commissioners for the Yorkshire Area for their consent to the running by the Council as part of their Omnibus Undertaking of Public Service Vehicles on the following route, namely:—

Commencing at the junction of Fountain Street and Bruntcliffe Road, along Bruntcliffe Road to the junction thereof with Bruntcliffe Lane, all of which said route lies within the Borough of Morley.

NOTE.—The above route is in relation to the proposed substitution of the existing Tramway Service operated between Leeds and Morley by a service of motor omnibuses.

Any objection to the said application by any Local Authority, County Council, or any persons who are already providing transport facilities on or in the neighbourhood of any part of the route to which the said application relates, may be made to the Traffic Commissioners at 44, The Headrow, Leeds 1, on or before the 5th day of February, 1935.

Any such objection should be in writing and should state clearly the grounds of such objection.

RIVER DEE CATCHMENT BOARD.

LAND DRAINAGE ACT, 1930.

NOTICE is hereby given that on the 13th day of December, 1934, an arrangement was made in pursuance of Section 40 of the above Act between the River Dee Catchment Board and the Dee Conservancy Board for the following purposes, viz.:—

(a) the transfer to the said Catchment Board of all the rights powers duties liabilities of and the property vested in the said

Conservancy Board in respect of four sluices situate in the Northern Embankment of the River Dee between Chester and Connah's Quay and so much of the Embankment as lies within a distance of seven and a half lineal yards on either side of such sluices, and

(b) the payment by the said Conservancy Board to the said Catchment Board of the sum of £750 for the commutation of the duties liabilities and obligations so transferred.

And notice is further given that a copy of the Arrangement and of the plan upon which is indicated the position of the said sluices may be inspected at the Offices of the said Catchment Board, 45, Nicholas Street, Chester, at all reasonable times within a period of one month from the date of the publication of this Notice.
