"(i) against an order made with the consent of the parties unless by leave of the Court or Judge making the order;

"(j) against an order as to costs only which are in the discretion of the Court, unless by leave of the Court or Judge making the order;

"(k) on behalf of a person, who has been admitted to sue or defend as a poor person, unless by leave of the Court or Judge, before whom the matter was heard, or of

the Full Court;

" (l) Against any interlocutory order or interlocutory judgment, unless by leave of the Judge or the Full Court, except in the following cases:-

(i) where the liberty of the subject or the custody of infants is concerned; (ii) where an injunction or the

appointment of a receiver is granted or refused;

(iii) against a decree nisi in a matrimonial cause or a judgment or order in admiralty action determining liability;

(iv) against an order refusing unconditional leave to defend an action:

(v) where rules of court prescribe that the order or decision shall be regarded as being of the nature of a final decision.

10. Article 123 of the Principal Order shall be amended by substituting for the words "Subject to the provisions of this order, an appeal shall lie to His Majesty in Council" the words "An appeal from decisions of the Full Court shall lie to His Majesty in Council by leave of the Full Court. Leave shall be granted as follows:-"
