shift in consecutive weeks and that suitable accommodation for clothing put off during working hours, adequate facilities for taking meals at or near the works, and washing facilities shall be provided; and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance, or otherwise for the welfare of such workers, as may be necessary to prevent hardship.
