

Archbishop of York, has executed this Scheme as hereinafter mentioned :

“ And whereas the transfer of the Patronage of the said Benefice of Nunkeeling which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Nunkeeling :

“ Now, therefore, with the consent of the said Robert Dixon, being the person whose consent as Patron is required by the provisions of the hereinbefore mentioned Acts and of the Act of the 1st and 2nd years of Her said late Majesty, Chapter 106 (in testimony of which consent he has signed and sealed this Scheme), and with the consent of the said William, Archbishop of York (in testimony whereof he has signed this Scheme and sealed the same with his Archiepiscopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Nunkeeling shall be transferred to the said William, Archbishop of York, and his successors in the same Archbishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said William, Archbishop of York, and by his successors in the same Archbishopric for ever.

“ And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.”

And whereas the said Scheme has been approved by His Majesty in Council :

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of York.

**WHEREAS** the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 6th and 7th years of His late

Majesty King William the Fourth, Chapter 77, of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 37th and 38th years of Her said late Majesty, Chapter 63, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 17th day of January, 1935, in the words and figures following, that is to say :—

“ We, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the 6th and 7th years of His late Majesty King William the Fourth, Chapter 77, of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 37th and 38th years of Her said late Majesty, Chapter 63, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme with respect to the Archdeaconries of Kingston-upon-Thames, Lewisham and Southwark within the Diocese of Southwark, and to some of the Rural Deaneries within such Archdeaconries :

“ Whereas the Right Reverend Richard Godfrey, Bishop of the said Diocese of Southwark, has represented to us that it is desirable to make certain new arrangements (being the arrangements hereinafter recommended and proposed) with respect to the said Archdeaconries of Kingston-upon-Thames, Lewisham and Southwark, and to some of the Rural Deaneries within those Archdeaconries :

“ And whereas we are of opinion that the new arrangements now proposed by the said Richard Godfrey, Bishop of Southwark, may properly be carried into effect :

“ Now, therefore, with the consent of the said Richard Godfrey, Bishop of the said Diocese of Southwark (in testimony whereof he has set his hand and affixed his Episcopal Seal to this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that as from the day on which an Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette and without any assurance in the law other than such duly gazetted Order, first, the name of the Rural Deanery of Kennington in the said Archdeaconry of Southwark shall be altered so that such Rural Deanery shall henceforth be called ‘ The Rural Deanery of Brixton and Kennington ’ ; secondly, the following Parishes shall be transferred to the said Rural Deanery of Brixton and Kennington, namely, the Parishes of Saint John, Angell Town ; Saint Matthew, Brixton ; Saint Paul, Brixton ; Saint Saviour, Brixton Hill ; Saint Jude, East Brixton ; Holy Trinity, Tulse Hill ; and Saint Matthias, Upper Tulse Hill, at present in the Rural Deanery of Clapham, in the said Archdeaconry of Southwark, and the Parish of Saint James, Camberwell, at present in the Rural Deanery of Camberwell, in the said Archdeaconry of Lewisham ; thirdly, the following Parishes shall be transferred to the said Rural Deanery of Clapham, namely, the Parishes of Saint Barnabas, South Kennington, and All Saints, South Lambeth, hitherto in the said Rural Deanery of Kennington, the Parish of Saint Luke, Battersea, and Saint Barnabas, Clapham Common, at present in the Rural Deanery of Battersea, in the said Archdeaconry of Southwark, and the Parish of the Ascension, Balham Hill, at present in the Rural Deanery of Streatham, in the same
